3. The above said staff car is parked at IDA Building, Jamnagar House, Shajahan Road, New Delhi. Interested persons/parties may inspect the above said car at IDA Building, Jamnagar House.

 - (ii) Date and time for accepting of Tender : 22.10.2020 upto 2.30 PM
 - (iii) Date and time for opening of Tender : 22.10.2020 at 3.30 PM

 - (v) The bidder is required to submit the quotation alongwith EMD (Earnest Money Deposit) of Rs. 2500/- in the shape of Bank Draft in favour of "Pay & Accounts Officer (NH), Ministry of SRTH, Jam Nagar House, New Delhi". The EMD of unsuccessful bidder will be returned within one or two weeks after opening of bid.
 - (vi) Quotations without EMD (Earnest Money Deposit) will not be considered and quotation would be treated as non responsive.
 - (vii) Successful bidder will be required to deposit the bid amount within 03 days by NTRP/demand Draft in favour of "Pay & Accounts Officer (NH), Ministry of SRTH, Jam Nagar House, New Delhi". In case, he fails to make deposit of the total amount as per tender within the stipulated time, the deposit including the earnest money shall be forfeited. The EMD of successful bidder can be adjusted at the time of final payment of tender value in time.

- (viii) The delivery of the sold vehicle will be given only after the successful bidder submits documentary evidence in support of residential status (PAN Card/Driving License/Voter ID Card/Aadhar Card etc.) and the payment of bid amount.
- (ix) The sold vehicle shall have to be taken at its own cost by the successful bidder within 24 hrs. on payment of bid amount.
- (x) The successful bidder will also be responsible for getting the Registration Certificate of the Vehicle transferred in his name at his own cost expeditiously within 15 days of getting delivery of the Vehicle. Copy of the documentary evidence for the same is to be provided to this office.
- (xi) The vehicle is not to be used by the buyer for any commercial/personal purpose till the transfer of registration on his/her name.
- (xii) The successful bidder shall not be allowed to withdraw the bid.
