

Minutes of meeting for technical evaluation for proposal of carrying out independent Road Safety Audits and suggesting rectification measures for 5 nos. of black spots for identified at (i) Gurudwara Nabha Sahib- Chandigarh Road (ii) Behak Gujran (iii) Tax Bariar Zirakpur-Ambala Road (iv) Bus Stand Shutrana (v) Bus Stand Dhabhi Gujran.

The meeting of evaluation committee to evaluate the bids technically as per the terms and conditions of RFP dated 07.02.2020 is held on 20.03.2020 in the Chamber of CE-RO, MORT&H, Chandigarh. In response to RFP issued vide RO-MoRT&H office letter no. RO/PB/RFP-BlackSpots/2019-20/3613-14 dated 07.02.2020, total eleven (11) numbers of bids were received as per following details:

2. The committee viewed the eligibility credential for all the bidders except at S.No 11, which was rejected at the outset only. Following clarifications were asked from bidders at S.No. 1, 6 & 8 vide this office letter no. RO/PB/RFP-BlackSpots/2019-20 dated 04.03.2020, to be furnished by 09.03.2020:

4. However, the agency, M/s JP Research India Pvt. Ltd. could not satisfactorily provide minimum experience of 7 years in Design, Construction, Maintenance and Engineering of Highway Projects as mentioned in Annexure-B of RFP (as the experience of key personnel as 'Principal Editor, Safety Speak! Newsletter, from 2012-15, has not been considered as relevant experience for the subject work). Accordingly the evaluation committee evaluated the technical bids and after due deliberations the committee found the bids of following bidders as Non Responsive.




