- 1) Expenditure is incurred only on sanctioned works (NHs and State Roads) in LWE affected area only.
- 2) No claim is entertained for expenditure incurred on any sanctioned works in excess of the sanctioned cost beyond permissible limits.
- 3) No expenditure is admitted on work/portion of the work where it might have been specifically advised not to incur any expenditure pending receipt/approval of certain issues/points, etc.
