The sanction of the President is also conveyed to allow ROs/RPAOs to admit expenditure against sanctioned Periodical Renewals (PR) works on purely First come first served basis henceforth during financial year 2019-20 out of the total overall allocation of ₹ 685.48 crore under Periodical Renewals (PR) for States/UTs/PIUs, subject to the condition that office of Principal CCA shall ensure that overall expenditure for PR is not exceeded at any point of time as these would ensure that bills pertaining to well performing States are cleared without any delay.
