

ROs/RPAOs are authorized to admit expenditure against sanctioned NH(O) works on purely First come first served basis henceforth during 2017-18 out of the total overall allocation for State/UT (i.e. Rs.13,235.31 crore); subject to the condition that office of Principal CCA shall ensure that overall expenditure for NH(O) is not exceeded at any point of time as these would ensure that bills pertaining to well performing States are cleared without any delay and there is no gestation period involved on account of the requirement to enhance their outlay at any stage in case the States allocation is/are fully exhausted as long as the total NH(O) outlay under NH(O) for State/UTs for entire Country is not fully exhausted.
