**OFFICE MEMORANDUM**

Whereas , 30(thirty) days " Show cause Notice" was served vide No. CE/NH/SARDP/NIT-2/2010-11(Pt-1) dated 16.01.2014 pertains to the non-compliance, non-maintenance of roads and very slow progress of works against the Work Order No. CE/NH/SARDP/NIT-2/2010-11 dated 04.02.2011 " Widening of 2-Lanning of Longleng-Changtongya Road, Mon-Tamlu-Merangkong Road, Phek-Pfutsero Road and Zunheboto-Chakhabama Road Under SARDP-NE in the State of Nagaland being executed by Maytas – Gayatri (JV), C/o. IL&FS Engineering and Construction Company Limited, Door No. 8-2-120/113/3/4F, Sanali Info Park, Cyber Towers, Road No.2, Banjara Hills, Hyderabad-500033 vide work order No. stating as to why the said Firm should not be debarred from further participation of any upcoming/future tender works in the State of Nagaland and rest of the country.

And whereas, the Firm has not replied to the Show cause Notice served thereupon. However, it is evident from the status monthly progress reports received from the respective Executive Engineers, PWD(NH), Kohima/Mokokchung and Executive Engineers, PWD(R&B), Pfutsero/Mon, the over all physical progress of works up to January '2014 is 20.18 % only out of the total project to be executed by the said Firm. Whereas, the terms of the contract agreement , the time period of completion was scheduled on 17.02.2014 and which is clearly indicated the laxity and incapability on the part of the Firm to execute the works within the stipulated period of time.

And, therefore, in view of the above reasons, the Maytas – Gayatri (JV) is declared incompetent and henceforth, debarred from further participation in all the upcoming/future tender works under PWD Nagaland. However, on satisfactory progress and improvement of their performance in future, the matter shall be reviewed by this Office imposing such debarment. It is also brought to the notice of the Ministry of Road Transport & Highways, Govt. of India, New Delhi not to entertain the said Firm in any tenders in National Highways or, and other Central Sponsored works elsewhere in the country.
